- The works consist of the rehabilitation of Marine Road and other adjacent roads located in the Port Area to be executed on a Design and Construct basis as more fully described in the bid documents.
- The intended completion period is eight (8) months.

Bids should be either deposited in the bid box located in the Chief Officer's Office, Mauritius Ports Authority, 1<sup>st</sup> floor, H. Ramnarain Building, Mer Rouge, Port Louis, Mauritius or submitted by registered post or courier so as to reach the Mauritius Ports Authority on or before **Tuesday 25 April 2017 up to 14.00 hrs. (local time) at latest**.

Bids will be opened in the Conference Room of the Mauritius Authority on the same day at **14.15 hrs**. in the presence of bidders or their representatives who choose to attend. Bids received after the specified closing date and time will not be considered.
