**CORROSION PROTECTION TO QUAY STRUCTURES AT PORT LOUIS HARBOUR
MPA 344/2017**

The Mauritius Ports Authority (MPA) is pleased to invite sealed bids from local and overseas bidders for the Corrosion Protection to Quay Structures at Port Louis Harbour as more fully described in the bidding document.

Scope of the Works

- Supply of aluminium anodes complete with fixing brackets etc for the tubular piles at Quays 1,2, 3 & 4 at Terminal II ; the sheet piles at Quays A,D,E at Terminal I; sheet piles at Trou Fanfaron and the sheet piles at Port Mathurin.
- Remove marine growth and scaling and prepare surfaces to receive aluminium anodes
- Install anodes in the quantities measured in the Bill of Quantities and as detailed in the drawings.
- The intended completion period is 270 calendar days.

Qualification requirements

- The Contractor must have a valid registration of at least grade C with the CIDB
- Other qualifying criteria mentioned in the bid document

Submission of bids

One original and 2 copies of the bid must be submitted in accordance with the Instruction to Bidders in sealed envelopes, clearly marked "**MPA 344/2017- Corrosion Protection to Quay Structures at Port Louis Harbour.**" addressed to the Director General, Mauritius Ports Authority, 1st Floor, H. Ramnarain Building Mer Rouge, Port Louis, Republic of Mauritius.

Bid Security

Bidders shall submit a Bid Security in the amount of **MUR 1,000,000 or USD 27,800 or EURO 25,700** in the format specified at Section III Bidding Forms of the Bidding Document. The bid security shall be in the form of an unconditional bank guarantee issued by a recognized bank in Mauritius or a foreign bank through a correspondent bank located in Mauritius.

Bids not secured as above shall be rejected.

Deadline for the submission of bids

Bids should be either deposited in the bid box located in the Chief Officer's Office, Mauritius Ports Authority, 1st floor, H. Ramnarain Building, Mer Rouge, Port Louis, Mauritius or submitted by registered post or courier so as to reach the Mauritius Ports Authority on or before **Tuesday 30 May 2017 up to 14.00 hrs. (local time) at latest.**

Bids will be opened in the Conference Room of the Mauritius Authority on the same day at **14.15 hrs. (local time)** in the presence of bidders or their representatives who choose to attend.

Bids received after the specified closing date and time will not be considered.
