The Mauritius Ports Authority (MPA) is inviting proposals from local Consultancy Firms to provide Consultancy Services for the Refurbishment of the Port Emergency Services and MPA Workshop as more fully described in the bidding document.

The bidding exercise will be conducted through the Open National Bidding method according to the rules and regulations issued by the Procurement Policy Office.

## The Consultancy Services comprise the following inter-alia:

- (i) Planning and Design of the required facilities to house all the necessary resources for the smooth running of the Port Emergency Services (PES) Unit and the Technical Services Section (TSS) to meet the present requirements and the future expansion of the respective Units.
- (ii) To recommend the most appropriate and economical option for the above taking into consideration the International Fire Coverage Standard, the requirements of Port Emergency Services (PES) Unit and the Technical Services Section (TSS) and the environment around the existing workshop.

#### **Eligibility**

The Consultancy Firm shall have undertaken at least one (1) project of similar nature and complexity (design and supervision of either a steel shed or a Fire Station) over the last fifteen (15) years.
